Employment has historically been perceived as a disincentive in the system of disability services and in the process of receiving benefits, but that is changing. Research has shown that employment needs to be incentivized because it aids in an individual's overall wellness, and is an effective tool in the process of recovery. The disability services organizations are working collectively to ensure that people with disabilities be made aware of their ability to work while keeping their benefits, simultaneously being able to move toward higher levels of independence.

Employment is just one tool to wellness. Our comprehensive system of services provides multiple pathways to wellness and recovery. It is essential to meet people where they are at; if employment does not serve the person at a moment in time, then employment can be discussed at a time that the individual is ready to move toward those steps. Sometimes, meeting a person where they are at means connecting with the individual in a moment of crisis or in a time they need to connect with another human being to navigate a difficult period in life. The Orange County Crisis Call Center and Dutchess County Stabilization Center are available tools in this type of moment. Individuals can utilize crisis services to remain well and in the community, also encouraging continuity of employment.

We are thrilled to bring together experts and professionals from various organizations to explore the vital role of employment as a pathway to wellness and recovery. We hope that this conference will spark meaningful conversations, provide new insights, and provide practical solutions for individuals to thrive in the workplace and beyond through the help of their support networks. She is a trainer for new police recruits and Stages of Change through the county-wide WELCOME Orange orientation for new employees. Ms. Henze is an instructor for the Credentialed Alcoholism & Substance Abuse Counselor program, NYS Impaired Driver Program, and National Traffic Safety Institute Defensive Driving. She is also an active member in many local committees and groups.

Ian Weinstein is a graduate of the State University of New York at New Paltz and has worked in the Human Services field for over 25 years. Ian began his career assisting families and individuals with developmental disabilities at Ulster-Greene ARC (now "The Arc of Ulster-Greene"). In 2001, he started working for Independent Living, Inc. to staff a new grant program supporting individuals who received federal disability benefits when they began the journey to employment or re-employment, ultimately managing the program from 2003-2017. Currently, Ian works as an Outreach Specialist for NY Connects, where he assists with setting up a variety of long term care services and supports for seniors and people with disabilities. Much of lan's work and expertise revolves around the application for, and maintenance of benefits and entitlements such as Medicaid, Social Security Disability Insurance, Medicare, Supplemental Nutrition Assistance Program (SNAP), among others.

lan is married to Cecille Castillon-Weinstein, who was just named as one of Hudson Valley's Top "40 under 40" by the Dutchess County Regional Chamber of Commerce for her growing Pepper Executive Concierge business.

Steve's unique models and approaches significantly reduce hospital utilization, incarceration rates, and overall healthcare spending.

Some of Steve's professional highlights with People USA include:

- •First in the United States to embed peers in a hospital psych. ER, paving the way for a evidence-based practice standard today.
- •Created the Dutchess County Stabilization Center; first peer-run crisis stabilization center in the United States.
- •Created the Transitional Care Wellness Team model, a unique hybrid of transitional care management and wellness coaching.
- •Created the Westchester Forensic Mobile Crisis & Response Team
- •Organized and provided Crisis Intervention Team (CIT) training to hundreds of law enforcement throughout New York.



Colleen graduated with a Master's in Rehabilitation Counseling from The University of Scranton.

Her first job in the field was job coaching. She has been working with Adult Career and Continuing Education Services-Vocational Rehabilitation (ACCES-VR) since 2017 and is currently working as a Senior Vocational Rehabilitation Counselor in the Middletown Satellite Office of the Mid-Hudson Office.
