



Expansion of Services



Independent Living diligently evaluates the needs of the communities we serve, reaffirming our dedication to tailoring our services to meet those needs directly. As a result, we expanded our service offerings to include new initiatives aimed at enhancing the quality of life for individuals with disabilities.

Facilitated Enrollment

Provide outreach and assistance to individuals who may be under or uninsured to enroll in benefits such as Medicare.

Safe Options Support

SOS Critical Time Intervention Teams will use an evidence-based approach to provide intensive outreach, engagement, and care coordination.

ADA Policy & Advocacy

An expansion upon existing services, Independent Living, Inc. established an ADA Policy & Advocacy team to address local and legislative barriers.

Youth Program

A service for individuals 18-25 who are aging out of school and/or the foster care system to be better connected to community supports and services.

Recovery Center

Independent Living, Inc. opened our Recovery Center, dedicated to providing peer support to individuals in mental health or substance use recovery.







IMPACT: Peer Services



Grounded in the principles of the peer services movement, our organization is driven by lived experience, employing experts in their respective fields.

Peer Services at Independent Living, Inc. encompass a unique and invaluable approach to supporting individuals with lived experience with disability, substance use, mental health, and/or trauma and recovery. Peers are individuals who connect with members or program participants through the lens of their own personal experiences, serving as allies and guides in the journey toward independence, recovery, and wellness.






